

ORDINANCE NO. 2023-

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE TOWN OF SAN FELIPE, TEXAS FOR THE FISCAL YEAR 2023-2024 BEGINNING OCTOBER 1, 2023, AND ENDING SEPTEMBER 30, 2024; PROVIDING FOR THE ADOPTION OF THE ANNUAL BUDGET FOR THE 2023-2024 FISCAL YEAR FOR THE TOWN OF SAN FELIPE, TEXAS; PROVIDING FOR A PUBLICATION CLAUSE, SEVERABILITY CLAUSE, REPEALER CLAUSE, OPEN MEETING CLAUSE, AND EFFECTIVE DATE.

WHEREAS, the Town of San Felipe, Texas (the "Town"), is a Type A General Law city operating under the laws of the State of Texas, by and through its duly elected Town Council members; and

WHEREAS, the Town Council must adopt a budget each year and the Town Council finds that the proposed Budget is for legitimate municipal purposes and is in compliance with Texas Local Government Code Chapter 102; and

WHEREAS, the Town Secretary has submitted to the Town Council a proposed budget of the revenues of said Town and the expenditures/expenses of conducting the affairs thereof and providing a complete financial plan for 2023-2024; and

WHEREAS, the Mayor of the Town of San Felipe has determined that the attached budget is necessary for the Town to function during Fiscal Year 2023-2024; and


WHEREAS, the budget for the fiscal year October 1, 2023, through September 30, 2024, was duly presented to the Town Council and a public hearing was ordered by the Town Council and a public notice of said hearing was caused to be given by the Town Council and said public hearing was held according to said notice.

NOW THEREFORE: BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF SAN FELIPE, TEXAS, THAT:

SECTION 1. The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

SECTION 2. The appropriations for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024 for the support of the general government of the Town of San Felipe, Texas be fixed and determined for said terms in accordance with the expenditures shown in the Town's Fiscal Year 2023-2024 Budget, a copy of which is attached and incorporated herein as Exhibit A.

SECTION 3. The budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the Town's budget for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024.



SECTION 4. The Town Secretary is hereby authorized and directed to publish the caption of this Ordinance in the manner and for the length of time prescribed by law. The Town Secretary is hereby directed to file the budget on the website of the Town and in the Town's official records.

SECTION 5. The provisions of this Ordinance are severable, and if any sentence, section, or other parts of this Ordinance should be found to be invalid, such invalidity shall not affect the remaining provisions, and the remaining provisions shall continue in full force and effect.

SECTION 6. All ordinances and resolutions and parts thereof in conflict herewith are hereby expressly repealed insofar as they conflict.

SECTION 7. The Town Council hereby finds and declares that written notice of the date, hour, place, and subject of the meeting at which this Ordinance was adopted was posted and that such meeting was open to the public as required by law at all times during which this ordinance and the subject hereof were discussed, considered, and formerly acted upon, all as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.

SECTION 8. The Town's Fiscal Year begins on October 1, 2023 and that fact requires that this ordinance be effective immediately upon its passage and adoption to preserve the public peace, property, health, and safety and shall be in full force and effect from and after its passage and adoption is hereby declared.



ORDINANCE NO. 2023-5

AN ORDINANCE OF THE TOWN OF SAN FELIPE, TEXAS APPROVING AND LEVYING THE AD VALOREM TAX RATE OF \$0.12220 PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE TOWN OF SAN FELIPE, TEXAS, FOR THE 2023-2024 FISCAL YEAR; PROVIDING FOR APPORTIONING OF EACH LEVY FOR SPECIFIC PURPOSES; PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN THE SAME SHALL BECOME DELINQUENT IF NOT PAID; PROVIDING FOR SEVERABILITY, REPEALER, AND OPEN MEETINGS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of San Felipe, Texas notified residents and property owners of the Town of San Felipe of its proposed tax rate as required by law; and

WHEREAS, the Town Council conducted a public hearing regarding the Town's proposed tax rate for Fiscal Year 2023-2024; and

WHEREAS, the Town Council of the Town of San Felipe, Texas has determined that the tax rate for the Town of San Felipe for Fiscal Year 2023-2024 should be \$0.12220 per \$100; and


WHEREAS, the Town Council of the Town of San Felipe, Texas shall set the property tax rate for the Town of San Felipe through the adoption of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SAN FELIPE, TEXAS, THAT:

Section 1. There be and is hereby levied and shall be assessed and collected for the Fiscal Year 2023-2024, on all taxable property, real, personal and mixed, situated within the city limits of the Town of San Felipe, Texas, and not exempt the Constitution of the State and valid state laws, an ad valorem tax rate of \$0.12220 on each One Hundred Dollars (\$100.00) assessed value of taxable property, and shall be apportioned and distributed as follows:

- (a) For the purpose of defraying the current expenses and budget of the municipal government of the Town of San Felipe (maintenance and operations (M&O)), a tax rate of \$0.12220 on each One Hundred Dollars (\$100.00) assessed value of taxable property.
- (b) For the purpose of creating a sinking fund to pay interest and principal maturities on all outstanding debt of the Town of San Felipe, not otherwise provided for, a tax rate of \$0.00 on each one hundred dollars (\$100.00) of assessed value of taxable property within the Town San Felipe which shall be applied to the payment of interest and maturities of all such outstanding debt.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE



RAISED BY 3.50% AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000.00 HOME BY APPROXIMATELY \$4.13.

Section 2. The Town Secretary shall cause the following notice to be posted on the homepage of the Town's internet website:

THE TOWN OF SAN FELIPE, TEXAS, ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.50% AND WILL DECREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,00.00 HOME BY APPROXIMATELY \$4.13.

Section 3. All taxes levied by virtue of this Ordinance shall be due and payable on October 1, 2023 and shall become delinquent after the 31st day of January 2024. If any person fails to pay ad valorem taxes on or before the 31st day of January 2024, the penalties and interest set forth under Section 33.01 of the Texas Tax Code shall apply.

Section 4. The Austin County Tax Assessor-Collector is hereby authorized to assess and collect the taxes of the Town of San Felipe, Texas, employing the above stated tax rate.

Section 5. The provisions of this ordinance are severable, and if any sentence, section, or other parts of this Ordinance should be found to be invalid, such invalidity shall not affect the remaining provisions, and the remaining provisions shall continue in full force and effect



ORDINANCE NO. 2023-6

AN ORDINANCE ADOPTING A HOMESTEAD EXEMPTION FOR RESIDENTS OF THE TOWN OF SAN FELIPE, TEXAS, WHO ARE DISABLED OR OVER 65 YEARS OF AGE AS ALLOWED UNDER TEXAS TAX CODE, CHAPTER 11.

WHEREAS, the Town of San Felipe has previously instituted a tax exemption for residents of the Town of San Felipe who are disabled or over 65 years of age; and

WHEREAS, the Town Council of the Town of San Felipe has determined that it is in the best interest of the citizens of the Town of San Felipe to provide a homestead exemption for residents of the Town of San Felipe who are disabled or over 65 years of age; and

WHEREAS, the Austin County Appraisal District has appraised the taxable value of properties and will need a determination of tax exemptions that have been approved for the Town of San Felipe as soon as possible.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF SAN FELIPE, THAT:

Section 1. In accordance with Texas Tax Code section 11.13, the Town Council of the Town of San Felipe hereby approves a tax exemption of \$5,000.00 for Fiscal Year 2023-2024 for individuals who are disabled.

Section 2. In accordance with Texas Tax Code section 11.13, the Town Council of the Town of San Felipe hereby approves a tax exemption of \$5,000.00 for Fiscal Year 2023-2024 for individuals who are over 65 years of age.

Section 3. The Town Council of the Town of San Felipe hereby authorizes the Mayor to forward this Ordinance to the Austin County Appraisal District upon its passage.

PASSED AND APPROVED BY THE TOWN COUNCIL OF THE TOWN OF SAN FELIPE, TEXAS, this, the 26th day of September 2023.
