

**ORDINANCE NO. 2026-2**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF SAN FELIPE, TEXAS CERTIFYING CANDIDATES AS UNOPPOSED IN THE MAY 2, 2026 GENERAL ELECTION FOR MUNICIPAL OFFICERS; CANCELING THE MAY 2, 2026 GENERAL ELECTION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Ordinance No. 2026-1 adopted February 10, 2026, a General election was ordered to be held on May 2, 2026, for the purpose of electing municipal officers to the Town Council of the Town of San Felipe, Texas; and

**WHEREAS**, the Town Council has statutory authority to cancel a General election for the purpose of electing municipal officers pursuant to Texas Election Code § 2.053 when the candidates are unopposed; and

**WHEREAS**, the Town Council finds that the General Election ordered for May 2, 2026 shall be canceled due to the candidates being certified as unopposed; and

**WHEREAS**, all constitutional and statutory prerequisites for the approval of this Ordinance have been met, including but not limited to the Open Meetings Act; and

**WHEREAS**, the Town Council finds this Ordinance to be reasonable and necessary under the circumstances; and

**WHEREAS**, the Town Council deems the adoption of this Ordinance to be in the best interests of the health, safety, and welfare of the public.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SAN FELIPE, TEXAS:**

**Section 1.** That all matters stated hereinabove are found to be true and correct and are incorporated herein by reference as if copied in their entirety.

**Section 2.** The Town Council of the Town of San Felipe hereby certifies that the following candidates are unopposed for election to office for the General Election scheduled to be held on May 2, 2026:

Alfreda Echols-Cloud – Alderman  
Alfred Hall – Alderman  
Wendy Sherman – Alderman

The Town Secretary is directed to post a copy of the Certification of Unopposed Candidates, which is attached hereto as Exhibit "A" and incorporated herein, at each designated polling location on May 2, 2026.

**Section 3.** The May 2, 2026 Town of San Felipe General Election for the purpose of electing municipal officers to the Town Council of the Town of San Felipe is hereby canceled. The Town Secretary is directed to post a copy of the Order of Cancellation, which is attached hereto as Exhibit "B" and incorporated herein, at each designated polling location on May 2, 2026.

**Section 4.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional, such holding shall not affect the validity of the remaining portions of this ordinance.

**Section 5.** All ordinances or parts of ordinances and resolutions or parts of resolutions inconsistent or in conflict herewith are expressly repealed.


**Section 6.** That this Ordinance shall be effective immediately upon passage.

**PASSED, APPROVED, AND ADOPTED** on first and final reading by an affirmative vote of the Town Council of the Town of San Felipe, this 10<sup>th</sup> day of March, 2026.

The following candidates have been certified as unopposed and are hereby elected as follows: Alfred Hall, Alfreda Echols-Cloud, Wendy Sherman.



